### WHICH SOLUTION SHOULD I CHOOSE?

BENEFITS PROBLEM	RECOMMENDATION
Increasing Premiums	An <b>HSA</b> with an HSA-compatible health plan typically has more affordable premiums, while the HSA provides an ideal tax benefit. An <b>HRA</b> with a higher deductible health plan can also provide savings opportunities for employers while providing more flexibility in the design of the health benefits.
Large Employee Expenses Early in Year	An <b>FSA</b> allows employees to manage large medical expenditures with an upfront allocation that is paid throughout the year.
Long-term Savings	An <b>HSA</b> provides an additional long-term savings vehicle similar to a 401K where funds carryover, can be invested and can be taken with employees when they leave. An <b>HRA VEBA</b> empowers employees to manage their healthcare expenses through employer-funded dollars while an active employee and often even during retirement.
Unique Employee Benefits Needs	An <b>HRA</b> or <b>HRA VEBA</b> allows an employer increased flexibility to design a unique reimbursement structure and provides a long-term savings vehicle.
Varying Insurance Products	An <b>FSA</b> can allow employees to set aside tax-free dollars regardless of the insurance offered. An <b>HSA</b> with a <b>Limited Medical FSA</b> allows employees with an HSA-compatible health plan to take advantage of an HSA's benefits while providing incremental savings towards dental and vision expenses.
