WHAT YOU NEED TO EFFICIENTLY MANAGE YOUR ACCOUNTS

Benefit Resource (BRI) has the resources you need to efficiently manage your tax-free benefit accounts.

BRIWEB

BRIWEB is your secure online login for managing your accounts with BRI. Key features include:

- Submit claims and receipts
- Update contact information
- View balance and transaction information
- Access Eligible Expense lookup table
- Download forms & other important files

To log in, go to BenefitResource.com/state-of-minnesota and select "Login to BRIWEB". If you have not created a Login ID and password, you will first need to register for an account on BRIWEB.



BRIMOBILE

BRIMOBILE provides on-the-go access to your account. Download the app today.

BRIALERTS

BRIALERTS provide real-time text¹ or email notifications regarding your accounts. Sign up through the 'Notifications' section of BRIWEB or BRIMOBILE. Types of alerts include:

- Card purchases and denials
- Monthly balance reminders
- Deposit information
- Duplicate transactions

ACCOUNT MANAGEMENT TIPS CHECK YOUR BALANCE

Before making a large purchase and on a routine basis, be sure to check your balance.

- Log in to BRIWEB or BRIMOBILE and view your balance by plan type.
- Select the BRIALERTS 'Monthly Account Balance Summary' option.
- Call Participant Services: (800) 300 1672. Select the option from the prompts to hear your card balance and provide your card number and CVV to have the automated system read you your account balance(s).

BE AWARE OF ANY DEADLINES

- Plan year expenses must be incurred by 12/31 (or the last day you were eligible for the plan).
- For MDEA, DCEA, and HRA accounts, complete reimbursement requests with documentation must be submitted or postmarked no later than midnight CT by the filing deadline of February 28 of the following year (29 if it's a Leap Year).

SAVE YOUR RECEIPTS & DOCUMENTATION

Pre-tax benefit accounts are governed by the IRS and may require proof that funds were used for eligible expenses. Learn more about this process by reviewing the "substantiation" resources at BenefitResource.com/state-of-minnesota
